INSTRUCTIONS

for the use of the Biathlon Centre "Südtirol Arena Alto Adige" Anterselva

General

All users from clubs and associations <u>must register</u> before using the biathlon centre!

You can register by phone or email.

It is important to notify the arena of your training sessions on time partly so we can coordinate any maintenance work at the shooting range, the route and in the stadium.

Please register no later than one day before using the facility.

Instructions:

1. General

- a) Use of the biathlon centre and all its facilities is by permission of the stadium management only. The responsible manager is Lorenz Leitgeb (stadium manager). Groups wishing to train must register for use of the facility in writing. Individuals may register by phone as above.
- b) The shooting range and the ski roller track are generally open from **8:30 am** to **12:00 am and from 2:00 pm to 6:00 pm**. Exceptions are possible. With regard to invoices named registration must be made with the stadium management no later than after the first training session.
- c) Vehicles must be parked in the car park by the main building. Vehicles may access the service buildings only with permission of the stadium management and only for loading and unloading purposes.
- d) Instructions by the stadium management must be followed at all times. Inappropriate behaviour can lead to removal from the premises.



- e) Please keep the facilities tidy. All waste must be disposed of in the waste bins. Fences and barriers must only be opened or removed with permission of the stadium management.
- f) Athletes up to 17 years of age must wear a helmet on the roller track!
- g) The Biathlon World Cup Committee is not liable for any accidents or damages. Use of the facility is at your own risk!

2. Shooting range

- a) Use of the shooting range is permitted only after prior registration with the stadium management. National and IBU safety regulations apply. The control panels can be obtained from the stadium management. Allocation of shooting stands is by the stadium management. The allocation of shooting stands is shown on the display board at the shooting range.
- b) A qualified shooting instructor must be present at all times. He must ensure that those present at the shooting range do not act in any way that risks avoidable dangers and that no spectators walk onto the shooting range. The shooting instructor must be named at the time of registration.
- c) Shooting is permitted only with air rifles and 22 calibre KK rifles. The weapons must be kept in the designated weapon stands. Weapons must be transported to the shooting range in a locked container.
- d) Users of the shooting range must be familiar with their weapon or be in possession of a firearms license or a certificate of competence.
- e) Walking on the shooting lanes is prohibited while the facility is in use.
- f) Cross over shooting is prohibited!
- g) In case of malfunction of the target equipment shooting must stop on all stands before a person can enter the danger zone. Before a supervisor enters the danger zone the shooting instructor (supervisor) must ensure that all weapons at the shooting range are open. They remain open until there is no person left in in the danger zone.
- h) Leaving the shooting range with a loaded rifle is not permitted.
- i) Where weapons are issued on the shooting range, the respective supervisor must ensure that these weapons are not loaded when they are handed over.

- j) The shooting stands must be left in a clean condition. Paper targets must be removed; cartridge cases must be picked up and deposited in the appropriate container. This is the responsibility of the nominated coach!
- k) Shooting mats are stored in the drying area and must be hung out individually over the designated hanging facility after use.

3. Ski roller - training track

- a) Due to cleaning use of the ski roller track before 8:30 am is not possible.
- b) Use of the ski roller training track is at your own risk. The operators accept no liability. Downhill runs may only be used with permission of the respective coach and only by experienced ski rollers. Before using the ski roller track the coach and the support team must inspect the roller track together with the athletes to point out any specific risks and dangers, particularly those associated with the downhill tracks.
- c) Use of the ski roller track training track is only permitted in the direction of movement (arrows). Please avoid standing still on the track.
- d) For your own safety we recommend that you always wear appropriate safety equipment.
- e) The track is closed while the sweeper is used on the ski roller track. This is always signed appropriately. (Sign: "Ski roller track closed! Sweeper on track!")
- f) The ski roller track runs through forestry and grazing land. It is possible that despite all fences and barriers cattle and vehicles may on occasion be found on or immediately at the side of the ski roller track. Please take extra care.
- g) Use of the ski roller track by pedestrians, cyclists and any vehicles is prohibited.

4. Charges

All charges are to be paid with the stadium management.
